Division: Tot (6&Under) Bantam (7&8) Intermediate (9&10) Novice (11&12) Senior (13&14)

Format: **Folkstyle**-Tot, Bantam, Intermediate- 4 man round robin. Periods (1-1-1 minute)
Novice &Senior- 4 man round robin. Periods (1-1 ½ -1 ½ minutes)
***Wrestlers cannot wrestle in more than one division.**

Weigh-Ins Sunday January 29th ,6:30-7:30 AM in Blackhawk Center Locker rooms, Wrestling begins immediately following bracketing.

Entry Fee: \$15 per wrestler (non-refundable). All wrestlers must be pre-registered with an individual entry form filled out. **No Walk-Ins Taken at the Door! Make Checks payable to Hawk Wrestling Club.** All Outstanding Balances and Individual Entry Forms are **due January 22, 2011**, unless other arrangements have been made. **No Refunds!** Coaches must have USA Coaching Card to be on mat side.
